A Europeen debate on reference budgets

Paris, 13 October 2015

While the European indicators on poverty are taking into account the living conditions of the most precarious populations, new indicators of wealth must be submitted back from now on to the French Parliament every year

In this context, the ONPES (Observatoire national de la pauvreté et de l'exclusion sociale) has carried out for the first time in France a project for developing reference budgets to fully participate in the society with a fresh view on this issue. It raises matters of substance and methodological questions as well.

This international symposium will focus on cross-countries comparisons, including the various approaches and goals, reflecting the diversity of expectations towards reference budgets from social actors.
